#### VIDYARTHI VIGYAN MANTHAN (VVM) 2021-22

#### India's Largest Science Talent Search for New India using Digital Devices

Vigyan Prasar, a National Institute for Science and Technology Communication established under Department of Science and Technology, Government of India, in association with National Council of Education Research and Training (NCERT) and Vijnana Bharati, is conducting the 10<sup>th</sup> Vidyarthi Vigyan Manthan (VVM) 2021-22 for school students of classes VI to XI on 30<sup>th</sup> November 2021 and 5<sup>th</sup> December 2021.

VVM 2021-22 will be India's first open-book science talent search examination to be held in 12 Indian languages and designed to be carried out using digital devices (App based). This 90 minute examination can be attempted by the students on any of the exam dates between 10:00 am to 8:00 pm from the comfort of their home and following all COVID norms.

Moreover, this year VVM is coming up with Mega Nation-wide Experiment based on the food habits of students, the nutritional value of the consumed food, and its environmental impact will continue this year as well.

#### Benefits to students:

- Knowledge about the Indian contribution to Science
- Know about one eminent Scientist and his/her work
- Learning through Hands on Activities
- Hone Leadership qualities among students
- Participation in Mega Science Experiment will enable the students to know about the nutritional value and environmental impact of our food habits.
- All the National level winners (18 students) and Zonal Level winner students (72 students) shall be undergoing an Internship-cum-Extensive Training Program (titled *SRIJAN*), in the leading R&D labs of the country.
- Bhaskara Scholarships shall be offered to all National level winners - *Himalayans* (18 students)
